Terms of Service

Accepting the Terms

These Terms of Service ("Terms") are a legal agreement between Enjoy Games Studio ("Enjoy Games" or "we") and you ("you"). By using or accessing any my game or application ("Service") you agree to be bound by these Terms.

By accessing or using the Service, you agree that you have read, understood, and accept to be bound by the Terms.
